TERMS OF AGREEMENT: The applicant, in consideration of being granted a sanction and other good and valuable consideration, hereby agrees to conform to and comply with the applicable Rule Book or approved Supplemental Agreements of the American Motorcyclist Association, or the All Terrain Vehicle Association (collectively, the "Association") and individually the "AMA" or the "ATVA", as applicable, governing the sanctioned activity and further agrees to indemnify and hold harmless the Association's officers, representatives and employees, from any and all liability, loss, cost or damage on account of any injury or death to any persons or property arising from or in any way resulting from the meet for which sanction is requested and associated activities, including all claims in consequence of the negligence of the applicant and employees, or by reason of improper premises, property equipment and conditions, and against all claims of liability and all loss, costs or damage of whatsoever kind and nature. The applicant further agrees to conduct the meet in compliance with all local, State and Federal vehicle laws wherever applicable.

In consideration of issuing a sanction, the Association, or its assigns, shall have all rights to broadcast any part or all of the sanctioned meet by radio, television, motion pictures or by any other means and to install the necessary equipment to do so in or about the premises and to retain all receipts there from for its own use. Any transcriptions shall be the sole property of the Association.

All advertisements must carry the wording "AMA Sanctioned" or "ATVA Sanctioned" and display the AMA and/or ATVA official logo as applicable. For the AMA logo use, please visit http://www.americanmotorcyclist.com/about/AMALogos.aspx. For the ATVA logo use, please visit http://www.atvaonline.com/ATVALogos.aspx. There you will find links to the bold new logo designs, and the terms and usage information. Please feel free to use the new logo as allowed by the terms of use and AMA/ ATVA Rules.

It is understood that the applicant is solely responsible for the condition of the track, fences, buildings and any other facilities and equipment as well as for the condition of the premises upon which the sanctioned meet is scheduled.

It is understood that the applicant is solely responsible for and agrees to withhold or pay any and all taxes, and to file any tax and informational returns, which may be occasioned by or arise out of this meet (including without limitation the payment of prize or other money to riders), and which may be required by any applicable federal, state or local laws.

It is understood that the applicant may apply for, and the Association in its sole discretion may grant, a sanction for activity comprising a distinct portion or portions of the applicants entire program; provided that said portion or portions of the program would, if held separately from the rest of the program, constitute activity sanctionable by the Association and otherwise comply with all of the sanctioning requirements of the Association.

IMPORTANT: THE APPLICANT MAY NOT AT ANY TIME ASSUME A SANCTION WILL BE GRANTED, REGARDLESS OF COMMUNICATIONS AND EFFORTS TO WORK TOWARD A SATISFACTORY PROMOTED MEET. PRIOR TO SUCH NOTIFICATION, ANY AND ALL EXPENSES (E.G., ADVERTISING, PRINTING, RENTAL, ETC.) INCURRED AND ANY ACTIONS TAKEN BY THE APPLICANT IN ANTICIPATION OF THE MEET ARE AT THE APPLICANT'S SOLE RISK. UPON INQUIRY, THE ASSOCIATION WILL ADVISE THE APPLICANT OF THOSE MATTERS REMAINING TO BE DONE BEFORE THE WRITTEN NOTICE OF SANCTION GRANT WILL BE ISSUED.

The applicant shall not use the following terms in the event title or advertising without express written permission of the AMA: Area, District, National, Regional, or State Championship.

In consideration of being granted an AMA sanction, the applicant agrees to submit required referee reports to the AMA within 14 days of the event. All AMA memberships sold must be returned within 2 days after the event. If the applicant fails to return the results/memberships within the allotted time, the AMA reserves the right to impose an administrative fee or take other action as appropriate.

AMA PREFERRED INSURANCE: The Association provides access to a Preferred Insurance Provider program as a service to all AMA Charter organizers. The coverage and rates listed on the AMA Insurance Options form apply solely to sanctioned events described within the AMA and ATVA rulebooks. Coverage for ancillary activities, entertainment, or exhibitions held in conjunction with a sanctioned event is not provided, unless such coverage is specifically agreed to with the insurer in advance of the sanctioned event and designated on the event certificate of insurance. Use of the AMA Preferred Insurance Provider for event liability insurance is strongly encouraged, though not required. Alternative insurance providers, as approved pursuant to procedures established by AMA, may be used.
